## **Hasketon Parish Council Precept 2018/19**

Each year the Council calculates the council tax base for the District. In doing so it derives the tax base from household changes on a Parish by Parish basis. Most Town and Parish Councils raise a precept to cover their own expenditure plans for the coming year. However, to gauge the effect of any proposals you might have in mind, it is important to be aware of anticipated tax base changes for the coming year and the likely effect of your proposals on local residents.

Based on the review of the Council's tax base for the coming year I anticipate that the tax base for Hasketon Parish Council will be 174.39 Band D equivalent properties.

This means that if your precept requirement was to be the same as for the current year 2017/18 (i.e. £8,514.92), this would result in a charge of £48.83 for a Band D property and this charge will show as -0.55% change on the 2018/19 Council Tax bills against the Parish element.

If the Parish Council wished to keep its tax charge the same as 2017/18 (i.e. £49.10) which would show as a 0% change on the 2018/19 council tax bill, a precept of £8,562.55 would need to be requested.

The charge for each property is calculated by multiplying the Band D charge by the appropriate scaling factor show in the table below.

In determining your precept it is often advisable to look beyond the requirements of the coming financial year and to make provision for projects and expenses further ahead. This allows you to have sufficient monies in hand to meet those costs without the need to increase precepts unduly in any one given year.

Precept requests of £600 and less will be paid in one instalment on 27<sup>th</sup> April 2018. For precepts greater than £600, 50% will be paid on 27<sup>th</sup> April 2018 and the balance within six months of the first instalment (28<sup>th</sup> September 2018).

Please note that if your precept exceeds £140,000, information will need to be provided of the 2017/18 and 2018/19 budget showing gross expenditure, gross income and net expenditure for your main service areas. This information will need to be submitted with the enclosed precept form and will be published in the 2018/19 Council Tax leaflet.

Please ensure that a signed copy of the attached form is returned to my Finance Team either via post to the address given at the bottom of the page or emailed to <a href="mailto:lauren.shelley@eastsuffolk.gov.uk">lauren.shelley@eastsuffolk.gov.uk</a> (preferred method).

As in previous years, the timetable for setting Council Taxes is very tight. It would assist me greatly if you could notify me of your precept requirement by no later than 19<sup>th</sup> January 2018 as the District Council is required to set Council Taxes on 22<sup>rd</sup> February 2018. Should you fail to notify me of your precept requirement by 19<sup>th</sup> January 2018, I will anticipate that your precept requirement for the coming year (2018/19) is the same as the previous year. **Under the Billing Authorities (Anticipation of Precepts)** (Amendment) (England) Regulations 2014, where the precept has been anticipated by the Billing Authority, the Parish Council is still required to provide a signed copy of their precept requirement by the 31<sup>st</sup> March 2018.
