

MINUTES OF EXTRAORDINARY MEETING OF HASKETON PARISH COUNCIL

**Held on Thursday 22nd July at 6.30pm in the Victory Hall Tymmes Place
Hasketon.**

Final Draft Minutes

Present: Parish Councillors (P.Cllrs) S. Dack (SD), A. Turner (AT), J. Withey (JW), S. Butters (SB) and David Keeble (DK)(Parish Clerk).

There was one member of the public in attendance.

- 1. Welcome:** Councillor SD assumed the Chair in the absence of both Chairman and Vice Chairman. SD welcomed those present to this Extraordinary Council meeting.
- 2. Apologies for Absence:** Apologies were received and accepted from Alastair McWhirter and Iain Whyte (personal reasons) and Becky Batley (work). District Councillor Colin Hedgley and County Councillor Elaine Bryce also offered their apologies.
- 3. Declaration of Interests:** None declared
- 4. Invitation for Members of the Public to Speak:** The MOTP in attendance spoke in relation to agenda item 7. The Chairman invited the MOTP to respond to any questions from Councillors in relation to item 7 arising during their considerations.
- 7. To Consider Planning Application DC/21/3221/FUL – Demolition of existing 3 bed dwelling, erection of replacement dwelling, Cherry Trees, Blacksmiths Road, Hasketon Suffolk. IP13 6JA.**

SB queried the realignment of the property boundary between Cherry Trees and adjacent Hill House, the foul sewer arrangements, and access. She commented the 1838 tithe map indicates a property in this location, and it is possibly shown on a watercolour painting by Thomas Churchyard. She considered the house not insignificant and would hope that as part of this process some historical research will be undertaken as was done when Church farm was demolished, and the barn was converted at Home Farm.

The MOTP responded regarding the realignment issue, foul sewer arrangements and the access.

The Chair reminded the meeting we could only consider the application in relation to the relevant planning issues.

It was resolved to offer no objections to the application with one abstention.
